PrescribelT®

Canada's national e-prescribing service - PrescribelT - is now available in Newfoundland and Labrador, with the first electronic prescriptions sent and received in Bonavista. PrescribelT makes prescribing easier and more convenient for Canadians, prescribers and pharmacists. It also improves patient safety and health outcomes, and protects patient privacy. As a key objective of the provincial electronic medical record program, eDOCSNL, e-prescribing enables a direct link between prescribers and pharmacists that will help reduce medication errors, improve medication adherence and speed up health care delivery. Information Requests

NLCHI is responsible for maintaining and protecting health information collected through a variety of sources, including health care facilities, pharmacies, clinics, government and research organizations. As part of its commitment to provide appropriate access to this information, researchers, health system managers and members of the public have a right to request information from NLCHI. **Click** to learn more about the information available and how to make a request.

Client Registry

One of NLCHI's initial projects was the creation of Canada's first Client Registry. This is a repository of patient demographic information that accurately identifies patients and links their data between different systems ensuring real-time authentication at the point of care. Every time you present in a health care setting, such as a hospital, and are asked your name, MCP, date of birth, family doctor - that system is the Client Registry. Each month NLCHI averages over 260,000 transactions between the Regional Health Authorities and the Client Registry. Its purpose is to ensure you are accurately identified when you present for health care.
